Vision Statement

To establish ourselves as the preeminent crypto-native investment fund, pioneering a new era of trust and collaboration in digital asset management. Our foundation is built upon three pillars: superior, data-driven trading strategies executed by seasoned experts; a fully transparent,



on-chain governance model that places decision-making power in the hands of our community; and an unwavering commitment to fair, automated profit-sharing that directly rewards participation.

Fundtir (FNTR) is a groundbreaking, tokenized investment fund—the first of its kind globally—designed to give investors complete freedom over their capital, with no restrictions, conditions, or fixed timeframes. Unlike trading platforms or tools that require active participation, Fundtir is fully managed by a team of trading professionals with over 20 years of combined experience in cryptocurrency, foreign exchange, stocks, futures, and derivatives.

This hands-off, professionally managed investment model combines the sophistication of institutional-grade trading with the transparency and inclusiveness of decentralized finance (DeFi). Continuous Protection: In addition to the initial audit, we have entered a one-year, renewable contract with CertiK for continuous cybersecurity protection. 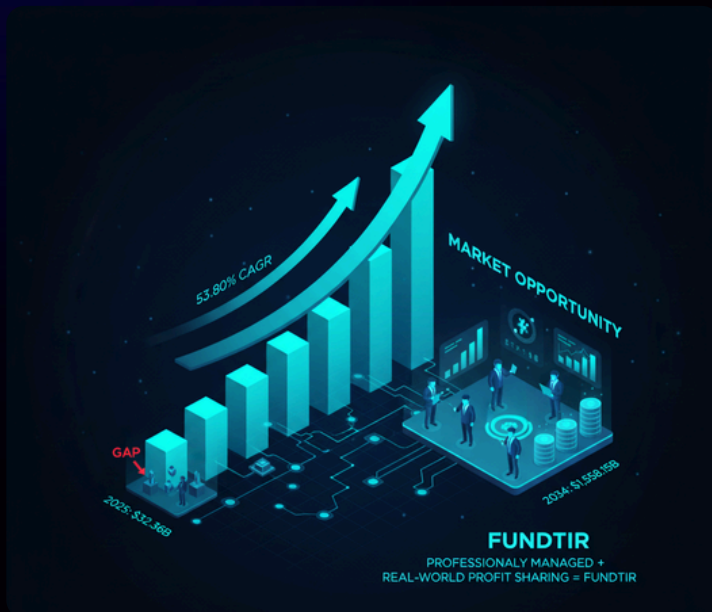

\$FNTR - The native utility token of the Fundtir ecosystem, pronounced "FUN-TER"

AUM - Assets Under Management; the total market value of investments managed by the fund

Biannual Distribution - Profit-sharing payments made to eligible token holders every six months

BVI - British Virgin Islands; the crypto-friendly jurisdiction where Fundtir will be incorporated

CEX - Centralized Exchange (e.g., MEXC, Bybit, OKX)

DAO - Decentralized Autonomous Organization; a blockchain-based governance system where token holders vote on key decisions

DAO Cabinet - A treasury oversight body that executes community-approved proposals and manages the DAO treasury

DeFi - Decentralized Finance; blockchain-based financial services that operate without traditional intermediaries

DeVC - Decentralized Venture Capital; community-driven investment in early-stage blockchain projects

ERC-20 - A technical standard for tokens on the Ethereum blockchain

FNTR2 - The planned second-phase token for Fundtir's future venture capital fund expansion

Fund Management Fee - The 2% annual fee charged on Assets Under Management for operational expenses

Governance Rights - The ability for staked token holders to vote on key project decisions

Liquidity Lock – The practice of securing trading liquidity for a specified period to prevent sudden withdrawals

Performance Fee – The 20% fee charged on net trading profits before distribution to token holders

Private Sale – The initial token offering phase for strategic investors with higher minimum investments

Pro Rata – Proportional distribution based on the percentage of tokens staked by each holder

Public Sale – The open token offering phase accessible to all qualified investors

Quorum – The minimum percentage of voting tokens required for a governance proposal to be valid

Staking – The process of locking tokens to become eligible for dividends and governance participation

Staking Eligibility – The requirement to stake tokens for at least 60 days before a distribution event to receive dividends

Smart Contract – Self-executing blockchain programs that automatically enforce the terms of agreements

Token Burn – The permanent removal of tokens from circulation, reducing total supply

TVL – Total Value Locked; the aggregate value of assets deposited in DeFi protocols

Vesting Schedule – The predetermined timeline for releasing locked tokens to prevent immediate selling pressure

Yield Farming – The practice of earning rewards by providing liquidity to DeFi protocols

Professional investment funds typically require minimum investments of \$1 million or more, effectively excluding 99% of potential investors from accessing institutional-grade trading strategies and risk management.



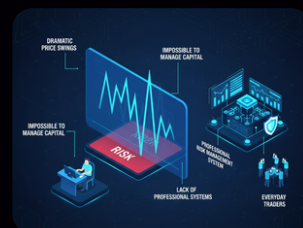

The British Virgin Islands (BVI) regulatory environment provides structured investor protection mechanisms similar to those of other reputable jurisdictions. The BVI Financial Services Commission (FSC) enforces clear requirements for fund registration, asset segregation, and AML compliance. While offering flexibility for digital asset management, the BVI's legal system ensures investor safeguards comparable to regions like Malta and Singapore, including transparent fund reporting, independent audits, and recognized dispute resolution procedures.

2. Expert Trading Execution

Our trading desk uses a mix of professional strategies designed to perform across different market conditions:

- High-frequency trading (HFT) captures short-term market inefficiencies and liquidity opportunities.
- Arbitrage takes advantage of price gaps between exchanges and trading pairs.
- Derivatives trading uses futures and options for hedging and tactical positioning.
- AI-driven quantitative models identify trends and optimize portfolio performance.

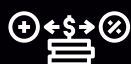

Utility Functions

Revenue that funds distributions is generated from the fund's professional trading operations, which utilize a combination of HFT, arbitrage, derivatives trading, and AI-driven quantitative strategies.



Dividend Eligibility: Only FNTR token holders who stake their tokens for at least 60 days prior to a distribution event are eligible to receive biannual profit shares from the fund's net trading profits.



DAO Governance Power: Staked tokens grant holders voting rights in the Fundtir DAO, allowing participation in strategic decisions including treasury allocations, token burns, marketing incentives, and upgrades.



Deflationary Mechanism: All unsold tokens from both private and public sales are permanently burned, reducing supply and potentially strengthening long-term token value.



Liquidity Protection: 25% of the liquidity raised in the public sale will be locked for 12 months on decentralized platforms, ensuring a secure trading environment for investors.



Staking Incentives: Only staked tokens confer governance rights and dividend eligibility, encouraging long-term holding and ecosystem stability.

- No equity ownership: The FNTR token delivers utility and governance rights not company ownership or guaranteed returns.

Additional Features

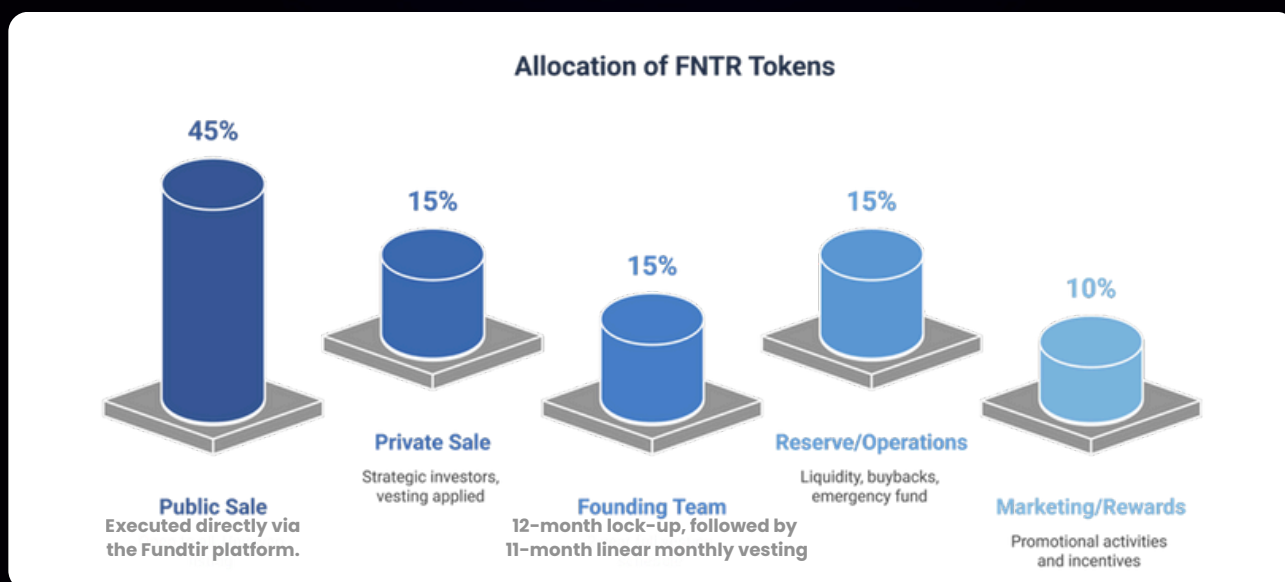
Tokenomics Philosophy

DAO Participation: Staked FNTR confers governance/voting rights, letting holders shape the treasury, burns, and future product development.

Rationale

Business Model Overview

Fundtir's business model seamlessly integrates professional asset management, decentralized token economics, and community-driven governance. By leveraging blockchain technology and expert trading strategies, Fundtir offers investors an accessible yet institutional-grade investment solution with transparent operations and real, recurring income.

How Fundtir Generates Value

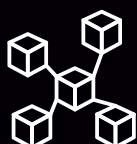
Fundtir operates as a tokenized hedge fund, pooling capital from FNTR token holders and deploying it across a portfolio of disciplined, professional trading strategies. Our execution framework blends high-frequency trading (HFT) for short-term opportunities, arbitrage to exploit cross-market price inefficiencies, derivatives strategies (futures and options) for hedging and amplified exposure when appropriate, and AI-driven quantitative models that inform medium-to-longer term allocation and signal timing. This multi-strategy approach aims to generate consistent net trading profits while minimizing drawdowns through conservative position sizing, volatility-aware risk controls, and automated execution safeguards.



- **Active Fund Management:** The team executes trades using proven methodologies, advanced risk management, and real-time oversight to maximize returns and minimize risk.



- **Tokenized Access:** Investors participate by holding (and staking) FNTR tokens, enabling entry without the high minimums or restrictions of traditional finance.



- **Decentralized Governance:** Significant decisions, including treasury usage and incentive programs, are proposed and voted on by FNTR stakers, aligning interests with the community.

How Revenue Benefits Token Holders

Dividends: After fees, net trading profits are distributed biannually to eligible FNTR stakers.

Definition of Net Profit and Distribution

Net Profit for the purpose of the semi-annual FNTR token holder distributions is defined as: **Total Realized Trading Profits, minus Management Fees (2%), Performance Fees (20%), and specifically itemized direct operating expenses.**

- **Direct Operating Expenses include:** Gas Fees, Exchange Fees, and the annual security and financial audit costs (Certik & our auditor to CROWE).
- **Cost Transparency:** An annual ceiling for Direct Operating Expenses will be proposed and voted upon by FNTR token holders via the DAO, ensuring transparency and safeguarding distributed returns.

Incentive Programs: DAO-managed treasury is used for airdrops, staking campaigns, and governance rewards.

Token Value Support: Strategic buybacks and permanent burns help maintain scarcity and price appreciation.

Sustainability Focus

All revenues and expenditures are transparently reported to the community. By combining real fund performance with accountable token economics and community governance, Fundtir delivers a scalable, sustainable business model built for long-term success.

Fundtir's robust, multi-channel revenue model aligns the interests of professional fund managers, token holders, and the broader crypto ecosystem—creating lasting value for all stakeholders.

9. Governance & DAO Framework

Decentralized, Transparent, Community-Driven Governance

Fundtir's governance is anchored in a Decentralized Autonomous Organization (DAO), empowering FNTR token holders to directly shape the fund's trajectory, operations, and ecosystem development.



Through a progressive rollout, Fundtir transitions from a professionally managed fund to a truly community-owned investment platform.

DAO Rollout: Four-Stage Implementation

DAO Transition Rationale & Interim Safeguards:

The gradual DAO rollout over multiple quarters ensures operational stability, regulatory alignment, and investor protection during Fundtir's decentralization process. A rapid transition could expose governance systems to exploitation or decision-making inefficiencies.

During the interim stages, community interests are safeguarded through:

- Multi-signature treasury control, requiring approval from both team and community representatives.
- Regular transparency reports summarizing all fund and governance activities.
- Snapshot-based advisory voting, allowing community feedback before full on-chain governance activation.

This measured approach balances decentralization goals with the need for accountability, technical maturity, and compliance readiness.

Governance Features & Participant Rights



Proposal Submission: Any address holding or delegated $>0.25\%$ of FNTR supply may submit proposals for review.



Community Feedback: Discussion periods (5–7 days) in forums for refining proposals.



Voting Period: Proposals are voted on over 3–5 days using staked tokens, either off-chain (Snapshot.org) or on-chain.



Quorum Threshold: Minimum 5% of circulating FNTR supply must participate for any vote to be validated.



Majority Approval: Simple majority ($>50\%$) required for most decisions, enabling fair and efficient governance.



Execution: DAO Cabinet executes approved decisions, gradually shifting to full smart contract-based automation.

Treasury Oversight & Community Funding



DAO Cabinet: Trusted representatives (from team + community) oversee treasury, disburse grants, and manage protocol upgrades.



Treasury Funding: 10% of fund trading profits are allocated to the DAO treasury for ecosystem development, grants, and community initiatives.



Transparent Audits: Treasury balances, expenditures, and grant allocations are published regularly for public verification.

Key Decision Areas Managed by the DAO

- Allocation of treasury funds for growth, incentive programs, and technical upgrades
- Token burn rates and deflationary measures

10. Development Roadmap

Stage 1 – Foundation & Initial Growth (Q3 2025 – Q4 2026)

Fundtir's first stage establishes the foundational infrastructure, community governance framework, and market presence necessary for sustainable growth and decentralization.

Q4 2025 – Initial Coin Offer Launch

The Initial Coin Offer (ICO) launches, combining private and public sale phases to raise capital from strategic investors and the broader community. Vesting schedules are implemented to ensure aligned incentives across all stakeholder groups.

Q3 2025 – FNTR Token Development

The development phase focuses on architecting and building the FNTR token with comprehensive security measures. Smart contracts are designed for staking mechanisms and governance participation, ensuring compliance with leading blockchain standards and security protocols.

Q4 2025 – Smart Contract Deployment

All Ethereum smart contracts are deployed and undergo rigorous third-party audits. The FNTR token enters its operational phase with staking mechanisms activated, enabling token holders to participate in the early governance framework.

Q1 2026 – Public Sale Launch via Fundtir Platform

The FNTR token enters its public sale phase conducted exclusively through the Fundtir platform.

This milestone marks the transition from private distribution to broader public participation and community engagement, while maintaining controlled execution and compliance.

Q1 2026 – DAO Framework Deployment

The foundational DAO governance structure (Stage 1) is deployed, introducing community voting mechanisms and proposal creation features. Community forums are launched for transparent discussion and collaborative decision-making on protocol development.

Q2 2026 – Tier 1,2 Centralized Exchange Listing

Fundtir secures listings on major centralized exchanges including MEXC, Bybit, and OKX, significantly expanding market accessibility and liquidity. Enhanced trading volume and institutional investor participation accelerate ecosystem growth.

Q3 2026 – First Profit Distribution & DAO Cabinet

The first biannual dividend distribution occurs, rewarding staked token holders with profits from fund performance. The DAO Cabinet is activated to manage treasury operations and execute community-approved proposals, representing a major governance milestone.

Q3 2026 – DAO Cabinet Activation

The DAO Cabinet becomes fully operational, taking on treasury management responsibilities and proposal execution functions. This structure balances community-driven decision-making with professional fund stewardship.

Q4 2026 – Full On-Chain DAO Implementation

Complete decentralization is achieved as all governance, voting, and proposal execution processes transition fully on-chain via smart contracts. Fundtir reaches community self-sustainability with transparent, immutable governance operations.



11. Future Vision Beyond 2026

Stage 2 – Ecosystem Expansion & Decentralization (Q1 2027 – Q4 2029)

The second stage builds upon Stage 1 foundations to create a fully autonomous, globally scaled ecosystem with advanced financial products and cross-chain interoperability.

Q1 2027 – Technical Preparation & Initial Marketing

Develop and audit the second-generation smart contracts for enhanced functionality and security. Build the new dashboard, allowing contributors from the first project to log in using the same username and password, ensuring seamless user experience. Launch the marketing campaign in mid-Q1 2027, focusing on digital outreach, media relations, and investor community building. Continue development and technical testing throughout Q1 and Q2, with full completion by the end of Q2 2027.

Q2 2027 – Unified Token Sale Launch

Begin the Unified Token Sale, combining both private and public sale phases under one transparent framework. Open participation to all investors through tiered pricing and verified registration. The token sale continues through the end of Q3 2027.

Q3 2027 – Sale Completion & DAO Governance Activation

Close the Unified Token Sale by the end of Q3 2027. Finalize and integrate the DAO governance system within the dashboard. Enable investor voting, proposal creation, and participation features.

Q4 2027 – Centralized Exchange Listing & System Activation

List the FNTR token on centralized exchanges such as MEXC, Bybit, and OKX. Activate the governance system through smart contracts and the dashboard interface. Publish the first annual report, summarizing financial and operational performance.

Q1 2028 – Commencement of Official Trading

Begin active trading of the FNTR token across centralized and decentralized markets. Monitor liquidity levels, trading volumes, and post-listing performance. Launch incentive and loyalty programs to strengthen community engagement and market stability.

Q2 2028 – Transparency & Financial Reporting

Release quarterly financial reports covering fund performance and trading results. Enhance the dashboard with real-time analytical tools and investor insights. Prepare for the first semi-annual profit distribution.

Q3 2028 – First Profit Distribution

Execute the first official profit distribution to eligible investors based on actual fund performance. Launch reward and incentive programs through the DAO. Conduct a comprehensive internal performance review to prepare for the next growth phase.

Q4 2028 – Strategic Review & Growth Planning

Conduct a comprehensive performance review after the first full year of trading. Update the investment strategy based on digital analytics, market trends, and investor feedback. Begin outlining the next-generation roadmap, focusing on scalability and cross-chain functionality. Onboard new institutional partners and prepare for regulatory expansion into additional markets.

Q1 2029 – Product & Service Expansion

Expand the investment portfolio to include new asset classes such as tokenized securities, commodities, and DeFi indexes. Launch Fundtir Labs as a dedicated research and innovation center to develop advanced strategies and tools. Release Dashboard 2.0, featuring advanced analytics and greater community interaction.

Establish strategic partnerships with leading FinTech firms, DeFi platforms, and global blockchain projects. Launch a Global Compliance Framework aligned with international regulations such as MiCA (EU).

Q4 2029 – Final Evaluation & Phase Conclusion

Publish the 2029 Annual Report, detailing growth metrics, strategic partnerships, and global community impact. Review and refine the expansion strategy to identify priorities for the upcoming phase, including asset diversification and service innovation.

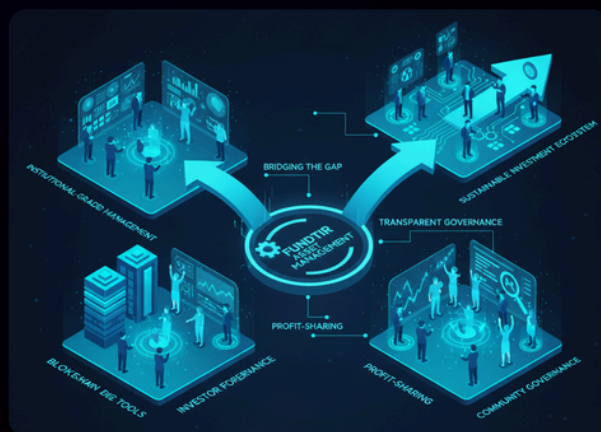
